## Llandudno Coastal Forum Consultation Comments

Walking on the beach is impossible for old and young alike, very dangerous indeed, it looks so false, very man made, and unnatural. Walking on the beach with stones - they collapsed and I fell over. Injuries will have to be dealt with differently, as people cannot carry a stretcher over cobbles and West Shore has not enough facilities to attract tourists so needs something doing.

The great strength of Llandudno is the traditional character. This is important when considering shoreline changes. Sand would be a great benefit to the town but concrete groynes very alien to the Victorian atmosphere. If shingle HAS to be used PLEASE make it shingle and NOT the current quarry rocks that are just referred to as shingle! Idea 2 for the Beach Zone combined with Idea 1 for the boating zone could be combined with a few traditional groynes in the middle of the beach.

It is essential that the rocks are removed and a better system of water control be in place. I would prefer wooden traditional groynes which have proved, over years, to work, and sand. Get rid of the stones!!!

All great ideas. But you need to do the one which provides best flood defence.

Imported sand version with high density hard wood groynes (sand version). Removal of added shingle/neck from entire beach to bring it back to its natural level. Raise the height of the defence wall behind promenade.

Extend the wall south to the pumping station will enhance the area and may also bring further investment. Sand management requires rethinking for the West Shore.

Costs associated with any major new works need to be externally sourced so as not to fall on Council Tax payer as much greater demands being made on public finances. Traditional groynes in many coastal areas quickly look tired and in need of work work/maintenance.

Thank you for the great effort that has been put into this project. We are old people, but Llandudno needs more to encourage families with smaller children. Everything at the moment is by the pier, and the rest of the bay is beautiful.

Preferably wooden groynes to reduce impact of environment.

I strongly support any project that will return Llandudno into being a traditional resort with sandy beaches.

Traditional groynes using recycled plastics would retain the traditional character whilst actively recycling. Sand is imperative to enhance Llandudno as a tourist destination for families.

Like Idea 2 with connected breakwater and groynes going toward Craig-y-Don. Breakwater for boat trips, protection, crab fishing. Suggest a crab fishing platform. LOVE the idea of redeveloping the paddling pool area - great design. Anything else RNLI can add to that development?

The West Shore used to be the coast favourite but is now used more because it is a safer option. Kids are throwing the stones on North Shore, and if an accident occurs, it will be difficult to extricate patient, when you have difficulty just walking across stones. It looks so wrong, and spoils the look of Llandudno. The B&B's will suffer because they used to see the beach, not cobbles. Ruined.

By the look of plans, the children's paddling pool is slap bang in middle of boating zone. Why not move it in beach zone?

Perfect opportunity to improve and protect. Llandudno is the Queen of Resorts.

Anything is better than the rocks we have at present.

The shingle / rockery has to go! Sand on the beach is required.

\* Sandy beach areas MUST be dog-free.

\* More parking at paddling pool area.

\* Maybe only setting down on hotel side until 6pm - then parking for hotel guests (with permit).

More sea defences for Craig-y-don

The need for a sandy beach on Llandudno North Shore is vital to the tourism of the area. Some car parking at the bottom of the little orme too. A sandy beach would be such an asset and bring families for miles here.

I feel that a number of traditional wooden groynes should be built similar to those that existed earlier. The cost would be cheaper than stoned groynes, any shingle (existing stones) to be removed where possible.

Beach zone - Sand variant

Boating zone - Shore connected breakwaters, Sand variant but only if modern attractive concrete structure otherwise would change vote to imported sand beach (Not Shingle) With traditional groynes.

1) Fixed beach huts would be inappropriate, impacting the visual sweep of the promenade; but why not create a "movable" beach hut based on the Victorian huts used at Llawm that could be used in summer and moved away in winter.

2) As long as appropriate "blending" from sand to shingle from the Boating Zone is undertaken, so there is not a sudden disruptive line.

3) The current unspoilt aspects of West Shore are greatly appreciated by many visitors, so it is important to maintain this and sustain it, rather than try and develop this area excessively. Improved accessibility would be welcome.

4) If designed properly, groynes should enable sand to deposit naturally - so importation should be a short-term measure with the aim to generate sand naturally.

Existing stones on the lower beach area should be moved away to reveal more of the existing sand. Kiddie's paddling pool needs to open at Easter onwards?

Concrete groynes would also provide access to beach as well as being longer lasting than wood.

Need to aim for a Colwyn Bay sand solution, the views from the Orme would be enhanced. Sand options will bring tourists into the town. Offer two fantastic bays for tourist proposition in Conwy. Paddling pools option looks great. Ensure sandy beach maintained at West Shore.

Look at Kinmel Bay. Higher sea wall would do better than rock shingle will.

THERE SHOULD BE A PUBLIC ENQUIRY into the waste of public money spent on the ridiculous stone dumping on the previous beach. The steps have been ruined - what will that cost to repair/review them. Idea 3 is what we had before. How outrageous that we have to spend thousands to restore what we had. Those responsible for the debacle of Llandudno beach should be held to account.

I feel that the boulders (or shingles as they call them) has really spoilt Llandudno - it can no longer be referred to as a beach resort. Colwyn Bay have spent a fortune in improving their beach. How sensible of them. Resting on our laurels at Llandudno will send future holidaymakers to other resorts. New plans for Craig-y-Don excellent.

This has been a waste of money. There should be a concrete barrier like Colwyn Bay.

Look at Kinmel Bay. Higher sea wall would be better than shingle.

Beach zone - looks fantastic, definitely new toilet facilities, wouldn't mind increased sea wall.

Beach management - all looks fantastic but realistic in these financial times. It would be excellent if monies found.

RNLI will need access to sea - could this act as one of the breakwaters?

Car park opposite Paddling Pool a good idea - please use grasscrete to make it visually similar to adjacent field.

Love the paddling pool ideas.

As a visitor, I don't feel able to add anything with much conviction. Wld prefer not to have concrete groynes as they don't wear well in longer term. Liked ideas for paddling pool area.

I am only a temporary visitor, and hesitate to express strong views. Good luck with your work! Llandudno is worth preserving!

As a regular visitor my view is Llandudno is a USUALLY windy spot so leave the pebbles and have GOOD SANDY area adjacent to the pier. All changes should relate to the weather in this region. It is not a sun worshipper area.

Until and unless CCBC admit they got it wrong on North Shore, nothing will change and all your time and effort will have been wasted. They have no intention, will or want, to remove the quarry rocks. Look into the legalities of what they did. Prove negligence. CCBC already have plans to dump more rocks within the next two years. Have you seen their licence to do that?

I believe we are driving away holiday makers with young families because we are a seaside town, and visitors expect us as a town to have sand rather than rocks on the beach.

The reason for the existence of Llandudno is tourism. This is unsustainable with beach facilities. The existing "shingle" is not proven to be effective nor safe - walking on it is hazardous.

1) Hydrographic surveys on final plans before decisions made.

2) Talk to pleasure boat operators about movements of tides and stones.

3) High secondary walls with gates should be installed in all options.

None of the proposed projects can be realised just asking peoples' opinions on what is the most beautiful or the most impressive by showing ideas. The beach itself has its own dynamics, which has to be thoroughly studied before acting. Currents, sedimentary (?) budget and tides need to be monitored constantly for at least a year! After that could be possible. Propose several remediation plans. The most ludicrous (?) project will be increasing sea wall height!!! I should write more but there is no space left!!

## Llandudno Coastal Forum Consultation Comments

I am not happy with the car park plan for Bodafon Fields. This is by a special needs school, which seems a strange choice, as road safety is not a strong point for special needs pupils. It will also increase traffic on a simple access road, which is already hard to pull out of onto the promenade.

I am very concerned about the proposed car park next to Ysgol y Gogarth. Vulnerable children make their way aided and unaided in and out of this school throughout the day, a huge increase of traffic and people would be very dangerous.

The most important thing is to protect Llandudno from sea flooding. This should take a precedence over any aesthetic considerations.

I would also support development of the paddling pool idea.

The West Shore lacks amusements for poor weather attractions.

How can there be no management required for the Ormes, it can't be self-sustaining with so nature life that needs to be protected. E.g "Yobs" who climb down to angel bay to harass the seals.

Laughable to use the term "Shingle" - They are ROCKS. VERY UNPLEASANT to walk acrosss to access the sand AND unattractive and inappropriate for a "Victorian Resort".

Our beach needs to return. Local and national people love Llandudno, no beach reduces the attraction. SAVE OUR BEACH AND TOWN.

Would the groynes be wood or plastic? Important that long term maintenance is agreed and at what cost. Don't be penny wise and pound foolish yet again.

But I do not like the groin from the pier

Idea No 3, all sand with traditional groynes as in Victorian times!! Cost will be better by doing one stretch at a time from the Pier.

My main concern is the safety of children at high tide. The sea looks an ideal area to paddle. We need some form of warning signs.

I would like to have a sandy beach back as it used to be in past years as I am a local girl. It would be lovely to see families back and their really enjoying themselves. If you want to go to a beach, we have to travel to Colwyn Bay.

Lots more sand excellent! As much sand as possible.

I don't support Beach Zone Idea 3. Variant with concrete groynes.

Without construction and long term costs displayed, I am unable to choose!

Keep all beaches dog free.

Why did not planners think about installing boardwalk access at intervals along existing shingle?

We would like Llandudno beach back to its former glory with sand, for the future of Llandudno and its tourism and young and old families who live here.

We need to define the term "shingle". We also need approximate costs associated with each suggested idea. Also - what will be the cost of removing the current boulders placed on the beach! Ongoing maintenance costs also need to be viewed.

Access to a beach on North Shore is fundamental for a destination attracting visitors. Return visits are guaranteed for years to come if a fun time is had on one's first visit.

The beach as it stands is nothing for the town. Sand will look much better. Families can enjoy the sand beach.

This should be a priority to achieve urgently. The present beach management is neither acceptable or efficient. Tourism is the lifeblood of the county and this MAJOR WELSH RESORT needs sympathetic beach management (SOON).

\* Anything to attract tourists.

\* Encourage marine life and include schoolchildren in education of our native coastal life.

\* Prevent another June 1993.

I think the boating zone area is a bit too adventurous unless there is a lot of spare cash. It is important to sort out the main beach area first. A decent café, toilets and shelters are adequate along with the paddling pool being kept in good order also a decent playground for the kids. After all the money spent on the new slipway by Venue Cymru and time spent on it, it should not need more money spending on it. Bad management! Toilets are a must, not sure about raising the height of the sea wall - depends how high.

As long as sea wall is not too high. Sort out sand blowing very important. Maybe more use could be made of the pond on West Shore. More toilets - free to use but locked after a certain time at night. Maybe look at the ones that self clean and doors open and close automatically. More seating needed at Craig-y-Don paddling pool. Share and publish the history of this area and you will get rewarded with positive public and visitor support.

Study the history of the area and you will get the answers!

Basically I endorse any plan which brings majority of beach back to sand. Craig-y-Don end seems to be the "poor ?" in regards to being looked after so any improvement would be welcome. Picnic tables on grassy area past paddling pool.

As Llandudno is a popular FAMILY resort, the removal of the "dangerous" large stones between the promenade and the sand should be strongly considered as they are, in my opinion, lethal to both young and old.

On separate sheet: Some of these could possibly used in the Llandulas project - to be replaced by smaller and smoother pebbles. An example of this idea can be seen at DINAS DINLLE seashore improvements where I do not feel that the flood defence improvements have been compromised. This is just a suggestion and may not be a feasible project however. (I have been a resident of the Caernarfon area for 37 years.)

My wife and I have a holiday home in Llandudno and were sad when all the rocks were dumped on the shore and strongly support the Save our Beach and the Coastal Forum. We prefer the traditional groyne approach in order to maintain the Victorian feel of Llandudno.

The existing (new) so called shingle management is a joke. This is not shingle, it's boulders. These boulders prevent people from using and accessing the beach. Bring back the groynes and then maintain them properly. If you had done this originally, we would not be in this position. We now face an uncertain future as our protective underwater bank - The Constable has now been ravaged to provide Colwyn Bay with miles of beautiful sandy beach.

Can the windblown sand reduction options include the cycle path south of West Shore, where at times it is impossible to cycle along it?

I strongly support the idea of bringing back the groynes and cannot believe the council approved the plan to do away/repair the old ones. Who was that person? Existing sand is needed without the shingle. Could a type of lagoon or part wall be built from the base of the Little Orme across to the Great Orme?

North Shore: Support for increasing the height of the sea wall will depend on how high. The recent addition of rocks (it is not shingle to anyone other than the chief engineer) is both unsightly and dangerous and should be replaced as soon as possible. A shallow slope made of sand is my preferred option, if it can be naturally maintained with the use of man-made structures.

West Shore: The current large grey stones are a nightmare that should not have happened. This is already a very shallow beach and I would have thought that something more peoplefriendly could have been found to protect the sea wall from breaching. The wind-blown sand is a problem but could be helped with slightly better management.

In general, while I recognize that flood protection is paramount, it is also important to understand that people live here and come to visit partly because of the beaches and easy access to them is vital.

Why couldn't we not put a sea wall on the prom side of the steps, running the length of the prom (North Shore)? Bring back traditional groynes on West Shore and get rid of stone (boulders) type groynes, going out to sea. Return it to its original condition.

Access for all needed, not just those who are active. The majority of visitors and residents are elderly/decreased mobility - please help us get back on our beach.

Having seen the way the tide flows in the bay - I think from the North East and the way the new slipway has rapidly become covered by stones and shingle for a second time, it occurs to me that if the curve of the improved and heightened slipway curved that shown on the plans it would deflect the force of the tide and provide a haven for craft being launched and later brought back to the slipway. It might also help the new lifeboat station.

My wife and I are soon returning to live. We would prefer to see sand on the North Shore if it is feasible. The current state of the 'beach' is horrible. The proposed idea plan 3 sand imported is the better option.

Colwyn Bay all sand! Who made the political decision to dump the rocks on North Shore?

Do not support the bike hire case. Generally, however, some excellent ideas to improve the North Shore for both residents and visitors

Could a skate park be fitted in anywhere?

Extravaganza = Last year 46 motor homes were counted that had stayed over night.

Would like sea pool built to left of pier by the 39 steps. One way traffic from roundabout near sailing club with herring bone parking on hotel side. Do not want Bodafon Field built on at all. Cycle path built behind 'New Seawall' Do like this idea of offshore breakwaters. Sand on Beach. No BOULDERS AT ALL. Do not mind if groynes on beach if made of wood

\*\* As long as the groynes are made of material that is easily maintained- perhaps the concrete groynes would be good option for that?

Strongly support removal of existing large core "shingle". Sand on beach zone in whichever form would be good. Strongly support a proper sea wall, like Colwyn Bay. Must have more toilet facilities.

As a resort Llandudno's beaches are its prime asset. The work which has been done recently is a huge mistake - hardly "victorian".

Boating Zone Idea 3 - recent shingle management has been appalling: large chunks of rock are NOT shingle and should be removed to return to the smaller shingle still present at Craig-y-Don.

Run the tourist train to the paddling pool.

At the end of the day I want what is best for Llandudno to keep it safe from flooding and an attractive place for the holiday makers to come and enjoy their holidays.

Prefer Idea 3 with imported sand but if engineering suggest sand alone not feasible would be happy for sand/shingle option.

I would hope to see Llandudno North and West Shore brought back to its former glory. We need to enhance what we have got, not make eyesores out of beautiful shorelines. We need to attract holidaymakers to our town, offer sandy accessible beaches and also provide things for people (locals and tourists) to do in wet weather. Replacement of a properly engineered bike path should be included if the recreation zone is to fulfil its purpose

Beach Zone - Support imported sand beach with traditional groynes to hold sand. Get rid of the shingle - it is dangerous and could result in an accident trying to get over e.g. mum with buggy, child & dog!

Unfortunately, there are no cost indicators/funding information. Therefore, my primary consideration is the ongoing effect of climate change and possible sea level rise - which I believe we cannot ignore, or if we do, it is at our peril.

With regard to civil engineering breakwaters, public safety would be a primary consideration.

Beach groynes do not work. Sand will build up on one side of groyne while sand will reduce on the leeward side. Causing uneven and dangerous levels from one side of the groyne to the other.

Boating Zone - Idea 1 much prefer the sand beach option to shingle variant particularly for boating access.

My ideal solution would be Idea 3 Imported Sand/Shingle beach with concrete groynes in the beach zones. I would suggest you "extend" the paddling pool to have a "sand pit". Please acknowledge this form - thanks.

The state of North Shore at present, with the "shingle" which actually amounts to small boulders, is inappropriately offputting to visitors.

FISHING ZONE - won't enhance look of area. It will be as bad as it is now.

If existing beach had not been tampered with a lot of money and disruption could have been saved, correcting the mistake.

Must be sustainable over a long period - aesthetically acceptable, able to be used for recreation and protects from flooding. New stones will quickly be removed by sea tides.

The imported stone is unacceptable.

While repairing and upgrading of facilities is necessary, I would ask that you do not lose sight of the fact that Llandudno prides itself on being a Victorian resort. Where possible, traditional materials should be used, eg groynes and beach huts.

- 1) Plenty of cafes in ? also will lead to more complaints of seagulls.
- 2) Mixed feelings - will this lead to too many bikes on prom, at present balance about right.
- 3) Not sufficiently familiar with area to enable me to comment.

I want it to be like when I came here on holiday when a child and also to bring my young grandsons to play on it and make sand pies and castles.

Please encourage more tourism, the only expanding industry in Wales.

It (would be) nice to have the sand back on the beach.

I think the main beach ideas are excellent, also the paddling pool is outstanding. My only worries are car parking may be needed - a multi storey, perhaps two levels. Also, make sure West Shore is within keeping with its beautiful views. We are the Queen of Resorts. Let's get that back.

We need as much sand as possible but we do (not?) need too many additional features such as beach huts because they would detract from the beauty of the bay. Offshore groynes would be ugly and possibly hamper sailing races and lifeboat operations.

Beach Zone - Idea 3 - Suggest shingle strip to the east of band stand ONLY.

Should height of sea wall be increased, suggest level access points with barriers which can be engaged (or disengaged) easily and preferably mechanically.

Storms and high tides in 2013/14 winter almost breached the prom wall, so sea defences must not be compromised by a general idea (of people who do not live in the potential flood area) of improving the appearance of the shoreline, necessary as that is. No plan viewed seems to provide adequate access to the sand - at least 4 needed.

Would support recreation zone as long as it would still be free to use pool.

Any improvements to the beach will bring families back to Llandudno.

All sand on North Shore - get rid of huge pebbles.

- 1) Some confusion with this form with respect to Recreation Zone / Beach Zone colour codings, etc (West Shore), between map and colour codings on listings (? etc).
- 2) The Venue Cymru slipway is a new facility (2014) and why does it now need raising and lengthening, is it not fit for purpose and if so, why not? (planning).
- 3) New public toilet facilities are important and much needed, but not sure about siting such facilities on the seafront if they are unsupervised and "free" (? they should be, as we all as taxpayers pay for such facilities).
- 4) Use of the artist impressions depicts what appears to be a shore connected breakwater in an arc at the pier end (North Shore). If this assists in retaining the sand further inland, then I would support this if modelling proves it can work.

Replacement of properly engineered bike path should be included in the Recreation Zone if it is to fulfil its purpose.

\* Sea defence is paramount. Cosmetic is also important for tourism.

NO SHINGLE all sand.

I firstly support examining the feasibility of off-shore breakwater and situated in a curved manner within our bay. With regard to the breakwater stretching from near the Pier. ? Site I would question this as if any lessons had been learnt of the Rhos on Sea breakwater, as over the years the sandbank up to the Promenade has over the years built up with silt. A play area there could be ruined.

I would like to see all stones, boulders and shingle removed ASAP from all our beaches. It would enable disabled and children access. It would once again become a family holiday beach.

\* Do not support the bike hire areas.

\* Do support the creation of a beach to aid visitors to our town.

Offshore breakwaters look terrible - connected breakwaters would provide an extra tourist attraction, ie being able to walk out into the bay. It would also create a brilliantly safe swimming area for local open water swimmers and triathletes who would train there weekly during summer.

It is important that there is no repeat of the disaster on North Shore on West Shore.

The beach needs to be more child and ? safe as well as having the correct flood barriers.

PUT CARPARK under the PROM where the tanks are.

Good sea defences and sandy beach.

Hope we get a sandy beach and sea defences.

In order to retain its Victorian character, may I suggest that beach huts be also incorporated into the Beach Zone and possibly to the Recreation Zone at West Shore.

Perhaps West Shore would benefit from TRADITIONAL beach huts as well.

Access to beach for all needs to be remedied ASP. We are a tourist town and beach access is important for all ages, disabilities, prams, etc.

Fishing Zone - not commented because I don't use this. Recreation zone under utilised. Ruined by yet more stone. Think the offshore/connected breakwaters will reduce the tidal flow, thus making it safer for young children to paddle.

Beach Zone - 3 only, if no shingle

North should not be segmented. It is ONE beach and all activities should work in harmony.

I like the idea of more facilities at Craig-y-Don.

I have lived here all my life and have never seen blown sand like we have now. Trinity Avenue was the only place to have blown sand before the groynes. Please do not destroy our beaches anymore. Time for re-instatement!

Keep the old shelters at the paddling pool - they work. The new café should reflect the design of the new lifeboat station.

Traditional wooden groynes with SAND.

With regard to the beach defences, if we get rain from the sky as in 1993 will there be adequate ways of draining off water so that the beach defences won't become a barrier to water falling within the Creuddyn peninsula.

In order to bring the foreshore as "world class", I propose that consideration be given:-

- 1) To create an underground car park beneath the promenade similar to that which exists in Estepona, Spain.
- 2) To widen the existing road by removing beachside pavement and verges (obsolete by virtue of wide walking prom - which also should be used in certain central areas as Al Fresco cafés/restaurants) - see patio at Queens Head, Glanwydden.

We have customers who have been injured walking on the shingle.

There has to be a balance between adequate sea defences and maintaining the aesthetics of the coastline. The current situation is too heavily biased towards sea defences and has ruined much of the North Shore. The new slipway is not fit for purpose and the extra stones create a safety hazard as there is now a large drop created. I do not believe there was the necessary due diligence carried out beforehand!

Recreation Zone - strongly disagree with use of sharp edged imported quarried cobbles - this denies young children access to drier sands. Use rounded dredged cobbles.

I would also like to see some traditional play activities, eg helter skelter, swing boats. No energy required to make them work except the energy of the child. Good for exercise and enviro-friendly. Not happy at all with off-shore breakers, over time would look ugly and encourage swimmers into deeper water.

All schemes in the running and model testing in marine labs.

Penmaenmawr promenade is testimony to the failure to maintain or advertise a wonderful beach. Beach huts have been vandalised. Planting areas badly maintained. Colwyn Bay and its sailing and not yet operating restaurant is further testimony to wasted funds. Restaurateurs should finance their own business!

Would be nice to see it as it used to be so I could bring my young nephews to play on the beach!!!

There are no costings or relative costing. We have to be realistic in what is achievable?

The opening of the promenade to cycles has made a previously secure walking area potentially dangerous to older and very young or handicapped walkers. Cycle hire would be likely to make matters worse.

Dog and waste bins at West Shore soon!!

The scheme would be a great boost for Llandudno and the surrounding area. It would increase family participation and visits. Water sports in a more controlled environment would flourish.

Sandy beach is vital to the heritage of our Victorian town - other aspects of the town are protected so protect our sandy beaches!

Boating Zone café - good, but not the one illustrated - a more conservative building please.

Support café idea, but not as illustrated on the CGI - a modern EYESORE on that!!

We do need to upgrade and modernise facilities to entice visitors (both day and long stay) to come again and again. Providing more facilities for children with or without disabilities can only help that.

Keep some of the shingle and add new "small" type shingle as the addition of sand only is bound to fail. The sea will "claim" the sand. No high buildings on the prom except for the RNLI, out of necessity but leave the prom as "empty" as possible.

Boating Zone Idea 3 - The "cobbles" which were dumped on the beach could not be classed as shingle. I hope that as I have supported a shingle beach it will now become just that - not an imitation quarry. The train should run through to the paddling pool area.

Llandudno beach is currently in a mess. I grew up here, I moved my family back here so my daughter could have the wonderful North Wales around her. We are disappointed and disgusted by the state of the rocks! How can our children play on that!?

If the excess stone is to be removed from the beach, what plans are in place to restore / replace / repair the stops? Do we really need more cafés? It's hard enough for existing ones to compete as it is.

I would strongly support the proposals for the North Shore beach, having lived in Llandudno and enjoyed the beach (until recent changes!) most of my life (48 years). I would also strongly support similar measures on the West Shore beach. I assume all disabilities would be catered for, as a matter of course!

Please consult BEFORE doing anything to West Shore beach and make sure wheelchair access is improved. I strongly support the proposals for North Shore beach.

So pleased that they have advised importing sand to give Llandudno a beach back again. The results in Colwyn Bay are excellent and I am sure will attract lots of new visitors this year at our hotels and shops expense. But urgent consideration must be given to access OFF our shores. Both North and West Shore as its leaving town open to being sued from people, especially disabled and people with difficulty trying to get back over the stones with the added stress of incoming tides. From an H&S position I would like to know how we were allowed to leave no designed access to and from the shores. (The suggestion to lengthen and raise the Venue Cymru slipway.) The company who designed and installed this as I hate to think what cost should be sued for wrongful design.

I feel that any beach huts, café or bike hire building designs should be in keeping with the look of the resort and should therefore be of traditional styling and not too futuristic.

I support all, anything is better than the rocks we have now.

Would like a much better, cleaner and safer beach area for families. Far too much shingle has spoiled an impressive sea front area. Needs to be comprised to maintain adequate sea defences and recreational amenities.

West Shore could be improved too, too many rocks there. Marine Zone Ormes - why not use the rocks from North Shore to protect the Ormes from erosion - recycle the rocks.

The new slipway by Washington Hotel should incorporate a split breakwater and so should any new developments to a slipway off Vaughan Street. Thus creating a wall either side of slipway to stop any ingress of sea water from gale force wind tides. A wave wall and elongated steps would dissipate waves on contact before any crossing to promenade, leaving all sand material at base of beach which would level out on every other tide.

**NO SHINGLE** - all sand.

West Shore needs reinstatement of the cycle path and there needs to be a continuation of a designated cycle route between West and North Shores.

I strongly support sandy beach with concrete groynes but with access for disabled (ramp) as well as steps.

Support beach huts if beach is sand. If the hovercraft starts to operate, where will it beach if the beach is left as it is now.

All the coastal forum ideas seem ok. By contrast, the 50,000 tonnes of rock was a horrid idea, slated by locals, hotels, visitors, for good reason. Equally reprehensible, the works were carried out in a deceitful manner: no advance notice, the "consultations" were a sham, non-existent. The motives of the council and its officials were, I feel, questionable. Public SERVANTS...huh!! That's a laugh!

I am concerned at what is being done to west shore. I have not seen Any consultation for any of the work being done and I am still unclear as to what work is being undertaken. I am astounded at the amount of money which has been thrown at Colwyn Bay. However someone at least took the time to plan how the money was going to be spent. It seems that whoever decided for how money should be spent in Llandudno opted for an easy option instead of being more creative. Thank you for taking the time to gather local people's views

The public consultation is excellent and a prime example of how communities and elected councillors should work together. Is there going to be a feasibility study on costing v amount of days at weekends and school holidays where the weather is warm enough for lots of families to be on the beach? I can only recall two hot sunny days last year, when the tide was in during the afternoon, and all the space was filled on the small sandy area. West Shore, via the train or walking, should be clearly signposted as a family friendly sandy beach. I still think money would be better spent on family friendly activities that can be accessed whatever the weather eg indoor/outdoor play areas and cafes on the eyesore by the grand hotel.
