5. LLANDUDNO BEACH MANAGEMENT PLAN

5.1 BMP - Executive Document (Owen Conry – CCBC ERF)

Mr Owen Conry (CCBC – ERF) had circulated the Executive Document of the Draft Beach Management Plan to Members for Feedback. Members gave additional feedback at the meeting. Ms Wareham (Forum Secretary) offered to summarise Members feedback points and sent those to Mr Conry via email. Members thanked Mr Conry for his work on the Document which was a great asset to have in addition to the Beach Management Plan.

Mr Conry (CCBC – ERF) confirmed that there would be a public consultation / drop in event for people to ask questions about the new Llandudno Beach Management Plan. This event would be arranged by Aecom and CCBC with support from Llandudno Coastal Forum Members. Mr Conry (CCBC – ERF) will contact Aecom and feedback to the Forum with possible dates for this event. This is likely to be in November.

Ms Debbie Wareham (Forum Secretary) has arranged a meeting with three CCBC CDS Officers, Mr Rob Dix, Mr Jon Merrick, and Ms Barbara Burchell to take advice about the help they can give the Forum to progress the additional funding and amenity development aspect of the project.
